

## International Student/NRI

De Paul College is affiliated to the Mandya University and we follow the guidelines of the University for the admission of International students and NRIs. The policy may vary from one academic year to the other depending on the policy of the University.

Candidates falling under any of the below mentioned categories must apply under the

### **International Student Category:**

1. Foreign citizens,
2. PIO (Person of Indian Origin) card holders and
3. OCI (Overseas Citizens of India) card holders

International students coming from Non-English speaking countries should:

- a) Produce evidence of passing the qualifying examination in English medium or
- b) Have IELTS 6.0 with no sub-score below 5.5 or TOEFL (paper) 550, TOEFL (computer) of 213 or TOEFL (IBT) of 79 scores.

Candidates without the above pre-qualifications will have to enrol for

Intensive Certificate course in English Language (Full Time) conducted from March to May each year or after the admission in the College campus.

### **NRI Student category**

Students who fall under any of the following classifications can apply under NRI Student category and be liable to pay the fees applicable to the category for the entire duration of the programme.

1. NRI defined under the Indian Income Tax Law
2. Either of the parents is outside India (except Nepal) on Work Permit / Resident Permit.
3. Indian citizen financed by any Institution / agency outside India, even if parents are Residents of India.
4. Indian Citizen who has pursued studies for qualifying examination in any foreign /

Indian syllabus outside India.

5. NRI fee is applicable for the full duration of the programme for candidates who;

5.1. Have pursued and completed their last qualifying exam from outside India.

5.2. Are NRI and candidates who have applied under NRI category.

Admission to all programmes is based on academic achievement and DE PAUL COLLEGE Selection Process. Candidates should submit the final results of class 12 on or before August 15th of the admission year.

Applicants must read through the Selection process, Fee Structure and other details under the preferred programme given on our website before proceeding with the following steps.

### **Application process:**

Note: The International/NRI Student category fee structure is binding on them for the full duration of the programme and cannot be transferred /changed in between.

Candidates from the above listed categories having pursued Indian Educational qualification and who may apply under the Indian States Category will have to pay the International Student Category Fee. The decision of the Admission committee is final.

Student seeking admission through International/NRI Student category will have a separate application process.

Kindly browse through the Selection process, Fee Structure and other details under the preferred programme given on our website before you could proceed with the following steps.

Candidates applying under International Student (Foreign Nationals/PIO/OCI) or NRI category have the below option to apply for any programme at De Paul College.

### **a) Online Application form**

Note: Candidates can use the online payment gateway only for your application processing fee transfer.

Applicants may apply for the programme from 12 January, 2025, when applications will be available online on the College website till the date applications will officially close.

### **Application Mode:**

Online mode: To fill and submit application using online mode, log on to our website <https://depaulcollege.in/> and click on “Admission Open”, proceed to click on the Application link, fill the application and submit. In the confirmation page click, on ‘Applications’ and click on the preferred programme.

### **Guidelines to applicants:**

Candidates should make sure that they enter the correct marks in the “previous qualification” field entry given in the online application form as this data will be carried forward for preparing the selection list. Any error in the marks entered will be treated as fraudulence/falsification of marks and the application will be rejected at any given time during the application/selection or admission process.

### **Copy of following documents:**

- a) Copy of Passport and VISA
- b) Copy of online payment Application Process Fee Receipt.
- c) 2 recent passport size and 2 stamp size photographs in formal dress of (Photo size of 35mm x 45mm with white background only - Standard Indian Passport Format only). The application may be rejected if the photograph is not according to the specification.
- d) The filled-in printed application form duly signed by the parent/guardian and the candidate.
- e) Copy of Statement of marks of Class 10 & Class 11/12, if applying for Undergraduate programme (Which ever applicable and available).
- f) Migration Certificate of 12th grade from the last qualified institution (Mandatory) must be submitted by date of admission.
