4. As the National Task Force is in process of preparing its interim report, it is imperative that all Higher Education Institutions shall fill-up the survey using their AISHE Credential immediately.

5. I therefore request you to treat this matter with utmost priority and ensure that the National Task Force (NTF) Institute Surveys are submitted by **29th October 2025 positively**. Institutions are also strongly encouraged to widely disseminate information about the surveys to all the stakeholders.
